Applicants who meet the minimum qualifications as stated on this announcement may apply to take this examination. Once you have taken this examination, you may not retake it 12 months.

All applicants must submit a signed <u>Standard State Application (678)</u> with any required educational documentation (if applicable). Once your application has been verified as meeting the requirements for admittance to the examination you will be **emailed** the Training and Experience Examination link. Please be sure to include your current email address on your application.

Applications are available through the internet at https://jobs.ca.gov/pdf/STD678.pdf and may be delivered in person or by mail. Incomplete applications will not be accepted. Applications must include: "to" and "from" dates (month/day/year), hours worked, civil service class title(s), for all work experience and exam code. Resumes will not be accepted in lieu of a State Application (STD 678). Applications received without the required documents will result in rejection from this examination.

POSITION DESCRIPTION

This is the entry level in the series. Under supervision, the Program Auditor, CalPERS assists in the planning, data gathering, analyzing, and reporting tasks associated with internal audits, evaluations and reviews, field audits, or special studies. The Program Auditor, CalPERS may also independently perform smaller or less complex assignments and/or assist in the completion of a segment of a larger or more complex assignment.

MINIMUM QUALIFICATIONS

All applicants must meet the education requirement as stated on this exam bulletin to be accepted into the examination.

Experience: No experience required. Applicants must meet the education requirement.

Education Requirement: A four-year college degree, preferably with a major in accounting, business administration, public administration, economics, mathematics, management information systems, computer sciences, computer programming, or a related field. (Registration as a senior in a recognized institution will admit applicants to the examination, but they must produce evidence of graduation or its equivalent before they can be considered eligible for appointment.)

NOTE: Your application will be rejected if you do not provide a copy of the required educational document transcript/degree which shows the completed college requirement at the time of filing the application.

NOTE: Your signature on your application indicates that you have read, understood, and possess the basic qualifications required.

DEFINITION OF TERMS IN MINIMUM QUALIFICATIONS

The words "equivalent to graduation from college" means applicant has received a bachelor's degree from an accredited college.

EXAMINATION SCOPE

Training and Experience Evaluation – Weighted 100% of the final score.

The examination will consist solely of a **Training and Experience Evaluation**. To obtain a position on the eligible list, a minimum score of 70% must be received. Applicants will receive their score upon completion of the Training and Experience Evaluation process.

Knowledge of:

- 1. Principles and practices of business and organizational management.
- 2. General accounting and auditing principles and procedures.
- 3. Elementary statistics.
- 4. Basic research methods.
- 5. Basic word processing and spreadsheet software.

Ability to:

- 1. Apply the required knowledge to a variety of situations.
- 2. Learn and apply general and specialized accounting and management auditing principles and procedures.
- 3. Learn and apply professional auditing standards.
- Review and analyze local government, State and Federal laws and regulations, accounting records and controls, management and other related controls, and program data.
- 5. Participate in interviews with staff at all levels.
- 6. Conclude as to the adequacy, completeness, accuracy, and fairness of financial data and/or financial statements with close supervision.
- 7. Prepare clear, complete, and concise work papers and reports to effectively communicate results of work.
- 8. Effectively incorporate the use of computer programs in performing evaluations, investigative tasks, preparing work papers, and reports.
- 9. Conclude as to the adequacy, completeness, accuracy, and fairness of financial data and/or financial statements with close supervision.
- 10. Assist in conducting performance, compliance, financial audits and evaluations of the department and entities doing business with the state agency.
- 11. Carry out methodologies to meet audit objectives.
- 12. Identify sensitive issues affecting assignments and bring to the lead auditor's attention.
- 13. Use a variety of analytical techniques to resolve problems.
- 14. Identify and analyze supporting audit evidence to develop appropriate conclusions.
- 15. Communicate effectively both verbally and in writing.
- 16. Work independently and in a team environment.
- 17. Learn and understand the department's mission, goal, objectives, core values and culture.
- 18. Learn and understand the department's business lines and operations.
- 19. Learn and understand the audit office's purpose, mission, objectives, and scope.

- 20. Interpret and apply sections of the laws, regulations, policies and procedures.
- 21. Maintain independence and objectivity while performing audit assignments.
- 22. Plan and prioritize to ensure that assignments are completed by the due dates and within the budgeted hours.

ELIGIBLE LIST INFORMATION

The eligible list for the **PROGRAM AUDITOR** classification will be established for **California Public Employees' Retirement System (CalPERS)**:

The names of **successful** competitors will be merged onto the eligible list in order of final score regardless of exam date. Eligibility expires **12 months** after the list established date. Applicants must then retake the examination to reestablish eligibility. **CalPERS vacant positions are located are in Sacramento.**

NOTE: The eligibility list can be used to fill vacancies statewide with other departments.

VETERANS' PREFERENCE

Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

Veterans' status is verified by the California Department of Human Resources (CalHR). Information on this program and <u>Veterans' Preference Application</u> (Std. form 1093) is available <u>online</u>. Additional information on veteran benefits is available at the Department of Veterans Affairs.

CAREER CREDIT

Career Credits will not be granted in this examination.

EXAMINATION INFORMATION

TRAINING AND EXPERIENCE EXAMINATION WEIGHTED 100.00%

The entire examination will consist of an evaluation of training and experience weighted 100%. The Training and Experience Examination is designed to elicit specific information regarding each candidate's Knowledge, Skills and Abilities relative to the testing classification. Responses to the examination will be assessed based on pre-determined rating criteria. All applicants must complete the entire examination to receive a score. The examination process takes approximately one hour to complete. All competitors will be ranked competitively based on the responses. In order to obtain a position on the eligible list, you must meet the examination requirements and must attain a minimum score of 70% on the examination.

NOTE: Be sure to include your current email address on your application. If you do not include your email address you will not receive the link to take the examination.

Employment History: Employment dates, job titles, organization names and addresses, names of supervisors or persons who can verify your job responsibilities, and phone numbers of persons listed above.

Education: School names and addresses, degrees earned, dates attended, courses taken (verifiable on a transcript), persons or office who can verify education, and phone numbers of persons or offices listed above.

Training: Class titles, certifications received, names of persons who can verify your training, and phone numbers of persons listed above.

Examination and/or Employment Application (STD 678) forms are available at the California Department of Human Resources, local offices of the Employment Development Department, and through your <u>CalCareers Account.</u>

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described in this bulletin will be rated against a predetermined job-related rating, and all applicants who pass will be ranked according to their score.

The California Public Employees' Retirement System (CalPERS) reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

Criminal Record Clearance Information: Upon employment, California Public Employees' Retirement System positions are subject to fingerprinting and a criminal record check requirement. This check will be completed by the Department of Justice. Applicants will be notified during the hiring process if the position is affected by the criminal record clearance procedure. The criminal record clearance is a condition of employment in positions affected by this procedure.

General Qualifications: Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.
