Caltrans is pleased to announce the posting of the **Tree Maintenance Supervisor**, **Caltrans** examination. Employment from this examination may be offered in all Caltrans Districts and Sacramento County.

# WHO SHOULD APPLY?

This is a Departmental Promotional examination for Caltrans. Applicants must be:

- 1) A permanent civil service appointment with Caltrans as of the final filing date in order to participate in the examination; or
- 2) Have been employed with Caltrans within the last three years, without a break in State civil service; or
- 3) A current or former employee of the Legislature for two or more years as defined in Government Code §18990; or
- 4) A current or former non-elected exempt employee of the Executive Branch for two or more consecutive years as defined in Government Code §18992; or
- 5) A person retired from the United States military, honorably discharged from active military duty with a service-connected disability, or honorably discharged from active duty as defined in Government Code §18991. Persons applying who qualify as a Veteran under Government Code Section 18991 must submit a copy of their DD214 with their Examination Application (STD. 678).

Candidates who meet the minimum qualifications as stated on this announcement may apply for this examination.

Candidates are required to submit a 1) Standard State Application (STD.678)

# **POSITION STATEMENT**

Under general direction, incumbents work with and supervise crews of workers engaged in trimming, shaping, cultivating and planting ornamental and shade trees and perform roadside vegetation control along transportation facility rights of way and at State facilities; perform aerial rescue when required; and perform other related highway maintenance work as needed.

## **ELIGIBLE LIST INFORMATION**

A Departmental Promotional statewide eligible list will be established for Caltrans in all Caltrans Districts and Sacramento County. The list will be abolished 24 months after it is established unless the needs of the service and conditions of the list warrant a change in this period.

# REQUIREMENTS FOR ADMITTANCE TO THE EXAMINATION

All applicants must meet the education and/or experience requirements for this examination by the final filing date. Your signature on the application indicates that you read, understand, and possess the minimum qualifications required, and that the information provided is true and complete to the best of your knowledge.

All applications must include: "to" and "from" dates (month/day/year), time base, civil service or private sector titles, the duties performed, and an original signature. Applications received without this information will be rejected.

**NOTE:** Qualifying experience may be combined on a proportionate basis if the requirements stated below include more than one pattern and are distinguished as "Either I," "or II," "or III," etc. For example, candidates who possess qualifying experience amounting to 50% of the required time of Pattern I, and additional experience amounting to 50% of the required time of Pattern II, may be admitted to an examination as meeting 100% of the overall experience requirements.

# **MINIMUM QUALIFICATIONS**

#### Either I

One year of experience in the California state service performing the duties of a Tree Maintenance Leadworker, Caltrans.

#### Or II

Four years of experience in the California state service performing the duties of the class of Tree Maintenance Worker, Caltrans.

#### Or III

Four years of experience in removing, planting, trimming, and caring for trees and shrubbery. This experience must have included working in trees at heights of more than 40 feet and the operation of heavy equipment. (At least one year of this experience must have been as a leadworker or supervisor of a tree trimming crew.)

# **EXAMINATION INFORMATION**

This examination will consist of a Supplemental Application Questionnaire weighted 100%. In order to obtain a position on the eligible list, a minimum score of 70% must be attained. It is anticipated that information regarding the Supplemental Application Questionnaire will be mailed in October/November 2016.

# **KNOWLEDGE AND ABILITIES**

#### **Knowledge of:**

- 1. Various ropes, knots, and splices to ensure proper tree pruning maintenance
- 2. Different cuts used for felling and limb removal to maintain the safety, health, and aesthetics of the tree
- 3. Appropriate rigging procedures using harnesses, ropes, saw chaps, etc. that allows for proper equipment and crew safety
- 4. Different types of climbing methods to remove and/or prune trees to provide for the safety and health of the tree
- 5. Pruning techniques to trim and/or remove excess tree limbs/branches to ensure public safety and the health of the tree
- 6. Safe Working Loads (SWL), Working Load Limits (WLL) in conjunction with Rope strengths in conjunction with wood weights to prevent potential hazards when elevated off the ground
- 7. Basic mathematics and formulas to ensure proper arboricultural operations
- 8. Operating and service requirements of various types of specialized equipment to ensure proper use for performing arboricultural practices
- 9. Equipment that is best suited for different types of trees to ensure proper pruning/removal techniques
- Safe pesticide application techniques to comply with (Department Pesticides Regulations) DPR

- 11. The minimum levels of tree maintenance as prescribed by Caltrans policy and Caltrans Maintenance Manual to ensure employee, public, and environmental safety
- 12. Proper signing, flagging, and lane closure procedures to ensure employee and public safety
- Safety regulations and practices when using Personal Protective Equipment (PPE) and hazardous chemicals to ensure employee, public, and environmental safety
- 14. Training techniques (e.g., maintenance and use of equipment, climbing techniques, arboricultural knowledge) to ensure tree maintenance is carried out in accordance with safety and Caltrans standards
- 15. Seasonal pruning requirements, to remain in compliance with laws, guidelines, policies (e.g., Migratory birds, protected species) to ensure tree crew is educated
- 16. Basic first aid and CPR to ensure tree crew's safety in the event of an emergency
- 17. Annual aerial rescue training and procedures to ensure the safety of tree crew in the event of an emergency
- 18. Procedures for treatment of diseases and pests that inflict trees to prevent the spread to other host trees
- 19. Tree identification and their growth patterns to ensure proper equipment is utilized for the maintenance of trees
- 20. Principles and techniques of effective supervision to ensure work is completed in a timely and safe manner
- 21. Current developments in equipment and materials used in tree maintenance to ensure optimal job performance
- 22. Botanical and common names of trees to identify diseases and pests for cultural practices and record keeping
- 23. A supervisor's role in Safety, Health, Equal Employment Opportunity Program and labor relations objectives and the processes available to meet these program objectives to ensure that department is in compliance

#### Ability to:

- 1. Climb trees in excess of 40 feet in height by means of harnesses, gaffs, and ropes to prune and/or remove weak or dead tree limbs to ensure employee and public safety
- 2. Perform tree pruning tasks at considerable heights above the ground to ensure tree is free of weak or dead tree limbs that may endanger the public
- 3. Coordinate body movements with tasks to be performed to ensure that task is performed safely
- 4. Select and apply knowledge appropriate to job tasks to ensure work is completed efficiently
- 5. Follow basic safety procedures for pesticide use and storage use to ensure safety of employees, public, and environment
- 6. Do the necessary rigging and tying of various knots used in tree pruning work to ensure the safety of tree crew

- 7. Follow oral and written instructions and location directions to ensure work is completed efficiently and within budget
- 8. Learn new methods and techniques to properly evaluate trees to ensure the health and aesthetics of the tree
- 9. Make independent decisions to ensure tree maintenance crew work is performed in an efficient manner
- 10. Establish and maintain cooperative working relationships to ensure group cohesiveness and successful job performance
- 11. Communicate in a clear and concise manner to ensure proper assignment of work and equipment to crew
- 12. Recognize potential hazards to ensure safety of the employees and public
- 13. Operate equipment such as chain saws, brush chippers, personnel hoist, etc. to ensure job is performed correctly
- 14. Plan and direct the work crew (e.g. equipment assigning, training) to ensure job is completed on time and efficiently
- 15. Evaluate the daily work performance of others to ensure safe operation and maintenance of tools and equipment
- Follow safe pesticide application procedures in compliance with Department of Pesticides Regulation (DPR) to ensure safety of employees, public, and environment
- 17. Effectively contribute to the Department's safety, health, Equal Employment Opportunity Program, sexual harassment prevention, and labor relations program objectives to ensure departmental compliance
- 18. Safely prepare, mix, apply and store pesticides to prevent injuries from occurring
- 19. Train others in the effective and safe use of pesticides to control disease, insects, and vegetation to prevent injuries on the job

# SPECIAL PERSONAL CHARACTERISTICS

1. Sufficient physical strength and agility to perform the essential functions of the job, including aerial rescue

## ADDITIONAL DESIRABLE QUALIFICATIONS

Possession of a valid and unrestricted Class B or Class A driver license with endorsements for P (Passenger/Bus), H (Hazardous Materials) and N (Tank Vehicle).

Possession of a Qualified Applicator Certificate with Landscape Maintenance, Rightof-Way or Forest Pest Control Category issued by the California Environmental Protection Agency (Cal-EPA).

# **DRUG TESTING REQUIREMENT**

Applicants for positions in these classes are required to pass a drug screening test. Testing of current employees who are applicants in an examination or who are transferring is permitted only if the person does not have a current appointment to a class for which drug testing is a requirement.

## **VETERANS' PREFERENCE**

Veterans' Preference will not be granted in the examination as it does not meet the requirements to qualify for Veterans' Preference.

# **CAREER CREDITS**

Career Credits will not be added to the final score of this examination.

## **GENERAL INFORMATION**

For an examination without a written feature, it is the candidate's responsibility to contact the testing department three weeks after the cut-off date if he/she has not received his/her notice.

If you meet the requirements stated on this bulletin, you may take this examination, which is competitive. Possession of the entrance requirement does not assure a place on the eligible list. Your performance in the examination will be compared with the performance of the others who take this test, and all candidates who pass will be ranked according to their scores.

**Caltrans** reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all competitors will be notified.

**General Qualifications:** Candidates must possess essential personal qualifications including integrity, initiative, dependability, good judgment, and the ability to work cooperatively with others; and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open

examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

**Eligible Lists:** Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) service-wide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

**Promotional Examinations Only:** Competition is limited to employees who have a permanent civil service appointment and military veterans that meet all the minimum qualifications. Under certain circumstances, other employees may be allowed to compete under provisions of Rules 234, 235, and 235.2. State Personnel Board Rules 233, 234, 235, 235.2, and 237 contain provisions regarding civil service status and eligibility for promotional examinations.
