## MINIMUM QUALIFICATIONS

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be accepted into the examination. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

All Classes:

Education: The required degree must have been obtained from a recognized U.S. university or from a foreign university approved by the Bureau of Private Postsecondary and Vocational Education under the provision of California Education Code Chapter 3, Part 59, Division 10.

### Research Scientist 2 (Various Specialties)

Either I

Experience: Two years of experience in the California state service performing scientific research duties comparable to those of a Research Scientist I in the [stated specialty](#) or a [closely related field](#). One year towards completion of a doctoral degree of the [stated specialty](#) or a [closely related field](#) may be substituted for one year of the required experience. and

Education: Possession of a bachelor's degree in the [stated specialty](#) or a [closely related field](#).

Or II

Experience: Three years of research experience in the [stated specialty](#) or a [closely related field](#). The research experience must have included responsibility for determining research design, choice of methods, and analysis of findings. The research involved in completion of the dissertation required for the doctoral degree may be substituted for one year of the required experience. and

Education: Possession of a master's degree in the [stated specialty](#) or in a [closely](#)

## **POSITION DESCRIPTION**

### **Research Scientist 2 (Various Specialties)**

Under general supervision, incumbents plan, organize, and carry out scientific research studies of moderate scientific scope and complexity; may serve as a team member on public health projects and investigations within their program and act as a technical scientific consultant on a specific phase of a more complex scientific research study; make independent, difficult decisions in a specific scientific field using established guidelines and technical scientific procedures and adapt research methods to problems with limited scientific scope, and perform other related work. Work is reviewed periodically to see that it generally conforms to established policies and procedures.

## **EXAMINATION SCOPE**

This examination consists of the following components:

**Training and Experience Evaluation** – Weighted 100% of the final score.

The examination will consist solely of a **Training and Experience Evaluation**. To obtain a position on the eligible list, you must provide education and the number of months of experience in the applicable parenthetical(s) specialty, and receive a minimum score of 70% on the exam. Applicants will receive their score upon completion of the Training and Experience Evaluation process.

In addition to evaluating applicants' relative knowledge, skills, and ability, as demonstrated by quality and breadth of education and/or experience, emphasis in each exam component will be measuring competitively, relative job demands, each applicant's:

### **Research Scientist 2 (Various Specialties)-Knowledge of:**

1. Current scientific research literature and trends applicable to the scientific research area
2. Principles and procedures of scientific research planning, design, methodology and analysis
3. Methods of preparation of scientific research reports
4. Scientific statistical methods and procedures
5. Data processing techniques
6. Bibliographic survey or previous related scientific research techniques
7. Determination and qualification of variables and mechanization of compilation of scientific data

### **Research Scientist 2 (Various Specialties)-Ability to:**

1. Evaluate the adequacy of proposed scientific research designs and techniques
2. Think independently and creatively
3. Establish and maintain cooperative relations with professional staff and with officials of Federal, State, local, university and private research organizations
4. Communicate effectively, prepare scientific articles for publication
5. Prepare scientific reports
6. Provide persuasive and skilled leadership to other staff in scientific research, principles and methods
7. Apply professional scientific knowledge and administrative ability to resolve a variety of situations
8. Analyze situations accurately and take effective action
9. Serve as team leaders on small scientific projects
10. Make independent, difficult decisions in a specific scientific field

## ELIGIBLE LIST INFORMATION

A separate servicewide, open eligible list for the Research Scientist 2 classification will be established for each of the following specialties: (chemical, epidemiology/biostatistics, food and drug, microbiological, physical/engineering and social/behavioral sciences). The list(s) you are placed on are related to the experience provided in the minimum qualifications portion of the exam.

State of California (all State of California departments, statewide)

The names of successful competitors will be merged onto the eligible list in order of final score regardless of exam date. Eligibility expires **twelve (12) months** after it is established. Applicants must then retake the examination to reestablish eligibility.

Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

Career Credits **will not** be added to the final score for this exam, because it does not meet the requirements to qualify for Career Credits.

## **GENERAL INFORMATION**

Examination and/or Employment Application (STD 678) forms are available at the California Department of Human Resources, local offices of the Employment Development Department, and through your [CalCareer Account](#).

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described in this bulletin will be rated against a predetermined job-related rating, and all applicants who pass will be ranked according to their score.

The California Department of Human Resources (CalHR) reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

**General Qualifications:** Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

**Eligible Lists:** Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

**High School Equivalence:** Equivalence to completion of the 12<sup>th</sup> grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification from the State Department of Education, a local school board, or high school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.
