# MINIMUM QUALIFICATIONS

#### **EITHER I**

Two years of experience performing the duties of a Deputy State Fire Marshal, Range B, in the California State Service.

#### OR II

**EXPERIENCE**: Five years of experience, at least three years of which shall have been in a lead or supervisory capacity, in any one or a combination of the following:

- 1. In fire prevention work in a public fire prevention bureau, unit or agency; or
- 2. On fire prevention or industrial safety engineering in private industry; or
- 3. In building compliance/inspection work in a public bureau, unit or agency.

(College training may be substituted for the nonsupervisory experience on the basis of two years of college being equivalent to one year of experience.) **AND** 

**EDUCATION**: Equivalent to graduation for high school. (Additional qualifying experience may be substituted for the required education on a year-for-year basis.)

# ADDITIONAL DESIRABLE QUALIFICATIONS

Tact and keenness of observation.

## **TYPICAL TASKS:**

A Deputy State Fire Marshal III (Supervisor) may supervise the office and field inspection staff, i.e., plan, direct, and control the work within a portion of a region; or supervise the review of plans and specifications for public and private buildings for compliance with panic and fire safety laws and regulations.

Incumbents consult with State and/or local fire, health, planning and construction officials, architects, engineers, and contractors on sensitive problems regarding panic and fire safety in the design, construction, and operation of buildings and other facilities subject to regulation by the State Fire Marshal; cooperate with other public agencies on mutual problems relating to fire safety; review reports and recommendations of field inspectors and prepare letters of instruction and recommendation to owners, grant code alternatives; make special field inspections with personnel in unusual or controversial problems; may conduct informal hearings and prepares cases for court, as required; oversee the application, within a portion of region, of all laws and regulations of the State Fire Marshal; conduct training meetings for technical field personnel; supervise field personnel in following up enforcement of laws and regulation of the State Fire Marshal; train new field personnel on inspection work and enforcement and evaluates their performance; counsel staff regarding disciplinary problems; and initiate punitive action as necessary.

This class supervises and trains subordinates in the review of plans and specifications for all occupancies, fire alarm systems, both manual and automatic, fire extinguishing systems, and modifications of existing buildings for compliance with panic and fire safety laws and regulations; advises the Office of the State Architect and other State agencies concerning the application of fire prevention laws and regulations in the design and construction of State buildings. Representing the State Fire Marshal, incumbents in this class attend meetings of fire prevention associations, service clubs and similar groups to give fire prevention talks and to present fire prevention material.

#### **ELIGIBLE INFORMATION**

A Departmental eligible list will be established for the Department of Forestry and Fire Protection. This list will be abolished 12 months after it is established unless the needs of the service and conditions of the list warrant a change in this period.

# REQUIREMENTS FOR ADMITTANCE TO THE EXAMINATION

Accepted applicants are required to bring either a photo identification card or two forms of signed identification to each phase of the examination AND the notice to appear showing the scheduled date and time of the exam.

#### **POSITION DESCRIPTION**

Under general supervision, either (1) supervises the field enforcement and office staff within a portion of a large geographical region of the state; or (2) supervises a highly specialized, technical enforcement program; and does other related work.

Through subordinate staff, incumbents in this classification administer the laws and regulations of the State Fire Marshal.

- 3. Applicable codes, standards, Department policies and procedures, and jurisdictional requirements for managing and resolving complaints for investigations and inspections.
- 4. Fire prevention and protection principles related to building construction and maintenance to meet code compliance.
- 5. Building occupancy classifications (e.g., prisons, high rises, hospitals) to understand the emergency response capability for panic, fire prevention engineering, education, and enforcement issues.
- 6. Proper grammar, spelling, punctuation, and sentence structure to ensure that written materials are complete, concise, and error-free for effective performance and communication.
- 7. Nationally recognized standards, regulations, accredited bodies, and/or laws relating to application of fire prevention engineering, education, and enforcement to develop regulations and ensure compliance.
- 8. Federal and State anti-discrimination laws to ensure compliance with the Equal Employment Office on lawful employment practices.
- 9. Fire behavior to evaluate building construction, products, and safety issues to ensure code compliance.
- 10. Department policies and procedures on communication (e.g., media, social media, public relation requests) to ensure compliance.
- 11. Fire behavior, building construction, products, safety issues, and regulation development to ensure code compliance.
- 12. The Department's safety procedures and programs (e.g., Injury and Illness Prevention Program, Violence in the Workplace, Workers' Compensation Program) to achieve workplace safety.
- 13. Building industry practices to read and understand construction documents.
- 14. Resources for supervision (e.g., progressive discipline, Employee Assistance Program, Equal Employment Office guidelines, Bargaining Unit Memorandum of Understanding, Employee Support Services) located on the California Department of Forestry and Fire Protection Intranet for guidance and tools for managing employees.
- 15. Nationally recognized standards, associations, regulations, and laws relating to the certification, licensing, and maintenance of products, fire protection systems, and equipment to develop regulations and ensure compliance.

- 16. Education, engineering, technical terminology, and principles for proper application to the job.
- 17. Permit, licenses, certification issuance, suspension and revocation requirements using applicable codes and standards adopted by the State Fire Marshal to ensure compliance.
- 18. Occupational hazards and appropriate safety precautions involved in construction, fire investigations, rescue and evacuation procedures, site inspections, and basic emergency medical operations to ensure public safety.
- 19. Modern fire protection principles and practices to evaluate alternative means, materials, and methods requests (e.g., building construction, fire equipment products, training) to ensure compliance and public safety standards.
- 20. The fundamentals of fire prevention engineering, education, and enforcement to provide technical expertise to industry specialists (e.g., architects, engineers, contractors, stakeholders) regarding application of codes to ensure compliance with regulations.
- 21. The requirements for submitting applications (e.g., plan review, licenses, code interpretations, accredited academies) to ensure compliance with laws and regulations adopted by the State Fire Marshal.
- 22. Industry standards of fire protection systems for fire prevention and suppression.
- 23. Peace Officers Bill of Rights and Fire Fighter Bill of Rights to ensure compliance with State laws and Department policies and procedures.
- 24. The operational responsibilities in the absence of the Division Chief, as directed, to ensure compliance with Department policies and procedures.
- 25. Department policies and procedures for conducting hiring interviews.
- 26. The various types of records and documents (e.g., inspection notices, curriculum, building inventories, official decisions, licenses, certifications) to understand required documentation and the statutory requirements for a records retention program.
- 27. How to compile evidence and information in preparation to present an expert witness testimony.
- 28. Publications, listings guides, codes and standards, and technical references for an effective job performance.
- 29. Potential stakeholders with shared concerns for available resources on issues of fire prevention engineering, education, and enforcement.
- 30. Budget procedures and revenue sources for funding purposes to meet operational needs.

#### Skill to:

- 1. Effectively communicate both verbally and written in English.
- 2. Use proper grammar, spelling, punctuation, and sentence structure to ensure that written materials are complete, concise, and error-free for effective performance and communication.

- 3. Operate computers and software programs effectively (e.g., e-mail, spreadsheets, presentations) to provide accurate reports and information exchange with Department employees and other public/private entities.
- 4. Operate all information technology devices (e.g., smartphones, computers, laptops) for correspondence, effective job performance, and communication.
- 5. Multi-task and meet deadlines.
- 6. Operate a variety of Department vehicles (e.g., all-terrain vehicles, snowmobiles, four-wheel drive) in a variety of weather and road conditions to ensure compliance with Department policies and procedures.

- 8. Gather, compile, and apply information and data from various sources for research, decision making, and developing action plans, for inclusion in written and oral reports, communication, and completion of assignments.

- 15. Use computer software programs (e.g., record and learning management system, e-mail, spreadsheet) to produce reports and effectively carry out daily assignments requiring communication.
- 16. Write technical reports to ensure proper documentation of information (e.g., investigation reports, correction notices) and summarize findings for an effective job performance.
- 17. Interpret codes and standards for successful job performance.
- 18. Read construction plans and identify symbols related to construction (e.g., electrical, mechanical, plumbing) to ensure code compliance and an effective job performance.
- 19. Document sensitive materials (e.g., litigation, appeals, correspondence) to create a record of events.
- 20. Effectively comply with the Department's Equal Employment Opportunity objectives.
- 21. Conduct inspections in facilities for code compliance.
- 22. Train staff, industry, stakeholders, and other Government agencies personnel on fire prevention engineering, education, and enforcement issues to ensure Statewide consistency.
- 23. Evaluate other regulatory agencies' regulations to negotiate and resolve conflicts regarding code development and enforcement for fire prevention engineering, education, and enforcement.
- 24. Think spatially to visualize the completed process (e.g., building plan to building completion) to apply codes for fire prevention engineering, education, and enforcement standards.
- 25. Effectively utilize the resources for supervision (e.g., progressive discipline, Employee Assistance Program, Equal Employment Office guidelines, Bargaining Unit Memorandum of Understanding, Employee Support Services) located on the California Department of Forestry and Fire Protection Intranet for guidance and tools for managing employees.
- 26. Deal with issues of a sensitive nature (e.g., trade secrets, proprietary equipment, patents, investigations) to maintain confidentiality matters.
- 27. Make oral presentations to educate and inform stakeholders on fire prevention engineering, education, and enforcement.

28. Facilitate meetings (e.g., committee, task groups, fire prevention) to achieve the goals of the Department and disseminate information to stakeholders.

## **VETERANS' PREFERENCE**

Veterans' Preference will be granted for this examination, pursuant to Government Code section 18973.1, effective January 1, 2014 as follows: 1) Any veteran, widow or widower of a veteran, or spouse of a 100 percent disabled veteran, who achieves a passing score in an entrance examination, shall be ranked in the top rank of the resulting eligibility list. Any veteran who has been dishonorably discharged or released is not eligible for Veterans' Preference. 2) An entrance examination is defined, under the law, as any open competitive examination. And 3) Veterans' Preference is not granted once a person achieves permanent civil service status. Veteran status is verified by the California Department of Human Resources (CalHR). Directions to apply for Veterans' Preference are on the Veterans' Preference Application (Std. Form 1093), which is available at CAL HR Veterans Information , and the Department of Veterans Affairs.

## SPECIAL REQUIREMENTS - FOR PEACE OFFICER POSITIONS ONLY

# **FELONY DISQUALIFICATION**

Pursuant to Government Code Section 1029, persons convicted of a felony are disqualified from employment as peace officers except as provided under Welfare and Institutions Code, Division 2, Chapter 3, Article 8, Section 1179 (b), or Division 2.5, Chapter 1, Article 4, Section 1722 (b). Except as provided for by these statutes, persons convicted of a felony are not eligible to compete for, or be appointed to, positions in this class. This felony disqualification applies only to those positions designated as peace officers.

#### **BACKGROUND INVESTIGATION INFORMATION**

Candidates selected for an appointment will be required to complete a Background Certification Statement regarding criminal convictions. A criminal conviction may preclude a candidate from employment; however, appointment commitments will be determined on a case-by-case basis.

# **CITIZENSHIP REQUIREMENTS**

Pursuant to Government Code Section 1031 (a), in order to be a peace officer, a person must be either a U.S. citizen or be a permanent resident alien who is eligible for and has applied for U.S. citizenship. Any permanent resident alien who is employed as a peace officer shall be disqualified from holding that position if his/her application for citizenship is denied.

#### **GENERAL INFORMATION**

**For all examinations (with or without a written feature)**, it is the candidate's responsibility to contact the Department of Forestry and Fire Protection, (916) 445-7824, three weeks after the cut-off/final filing date if he/she has not received a progress notification or notice to appear.

**If a candidate's notice** of oral interview or performance test fails to reach him/her three days prior to their scheduled appointment due to a verified postal error, he/she will be rescheduled upon written request.

**Examination Locations:** When a written test is part of the examination, it will be given in such places in California as the number of candidates and conditions warrant. However, locations of interviews or performance evaluations may be limited or extended as conditions warrant.

**Applications are available** <u>online</u> at CalHR, local offices of the Employment Development Department and the testing Department on this job bulletin.

**If you meet the requirements** stated on this bulletin, you may take this examination, which is competitive. Possession of the entrance requirement does not assure a place on the eligible list. Your performance in the examination will be compared with the performance of the others who take this test, and all candidates who pass will be ranked according to their scores.

**The Department of Forestry and Fire Protection** reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all competitors will be notified.

**General Qualifications:** Candidates must possess essential personal qualifications including integrity, initiative, dependability, good judgment, and ability to work cooperatively with others; and a state of health consistent with the ability to perform the assigned duties of the classification. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

**Eligible Lists:** Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) Departmental promotional, 3) multi-Departmental promotional, 4) service-wide promotional, 5) Departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

If High School Equivalence is Required: Equivalence to completion of the 12th grade may be demonstrated in any one of the following ways: 1) passing the General Educational Development (GED) Test; 2) completion of 12 semester units of college work; 3) certification from the State Department of Education, a local school board, or high school authorities that the candidate is considered to have education equivalent to graduation from high school; 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.

**Confidentiality and Security:** Pursuant to Government Code Sections 19680(c) and 19681(b) it is unlawful to copy and/or furnish confidential examination material for the purpose of either improving or injuring the chances of any person or to obtain examination questions or other examination material before, during, or after an examination. Every person violating these provisions is guilty of a misdemeanor, and adverse action will be pursued. This may result in the person being barred from competition in future examinations, withheld from certification lists, or cancellation of eligibility for employment in State civil service.

**Felony Disqualification:** You are disqualified from being employed as a peace officer if: 1) you have been convicted of a felony in California or any other State; 2) you have been convicted of any offense in any other State which would have been a felony if committed in California; 3) you have been charged with a felony and adjudged by a superior court to be mentally incompetent; 4) you have been adjudged addicted or in danger of becoming addicted to narcotics, convicted, and committed to a State institution. If you have been convicted of a felony, you may be allowed to participate in this examination if your conviction(s): 1) has/have been sealed under Penal Code Section 851.7, 851.8, 1203.45, or Health and Safety Code Section 11361.5; 2) has/have been expunged or is/are expugnable pursuant to Health and Safety Code Section 11361.5 regarding marijuana offenses; 3) was/were stipulated or designated to be a lesser included offense of marijuana possession under Health and Safety Code Section 11557 or 11366.
